Compliance FAQs - Coronavirus

The *Families First Coronavirus Response Act* ([H.R. 6201](#)) enacted on March 18, 2020 addresses many issues. Specific to employee benefits, it provides for mandated health coverage for coronavirus testing and related services, emergency paid sick leave, and emergency family and medical leave. The law also provides for a dollar for dollar tax credit for providing emergency leave, as well as tax credit for providing certain health coverage continuation for employers impacted by the coronavirus.
